Annex III

Annex III definerer specifikke krav i forhold til anvendelse af AI i forbindelse med uddannelse. Et system defineres som høj-risiko hvis:

- 3. Det anvendes til at afgøre placering på uddannelsesniveau
- 4. Det anvendes til overvågning eller detektion i forbindelse med prøver

Om konventionen

EU har underskrevet konventionen på vegne af medlemslandene

- Den er også underskrevet af en række andre lande, som f.eks. USA, Storbritannien, osv
- Ingen lande fra det globale syd har underskrevet

Konventionen har fokus på menneskerettighederne ved brug af Al

- Den overlapper delvist med både Al Act og GDPR
- Men har også en række unikke detaljer

Da det er en konvention ved vi endnu ikke hvad den præcise lovtekst bliver eller hvornår den træder i kraft

- Først skal både EU og medlemslandene ratificere konventionen
- Derefter skal den implementeres som en eller flere love (el. lovændringer)





Om læring

- Tavleundervisning er død, med få undertagelser
- Underviserens opgave er at støtte de studerende på deres vej gennem det i forvejen forberedte materiale

Rammerne vil stadig være forskellig, f.eks. fysisk, traditionelt online, muligvis noget VR/AR

 Men undervisningen vil i højere grad foregå på de studerendes præmisser – Ikke alle er samme sted i materialet på samme tid

Om materialerne og det sociale

Materialerne bliver i højere grad multimodale, så det samme kan læres på flere måder

- Det vil være reglen, nærmere end undtagelsen, at materialerne har en AI tilknyttet som kan besvare spørgsmål
- Med AI har de studerende en assistent de kan tale med 24/7

Vi vil gøre en ekstra indsats for at lære de studerende at faktatjekke og genkende Alproduceret materiale

• Der vil også være fokus på tilpasning af Al-produceret materiale, frem for egen produktion


